Line 28 - In 2019, Circles RVA continued to engage its first cohort of Leaders who started the program in August 2018. In March 2019, Circles RVA launched its second cohort of Leaders and in September 2019, we brought a third cohort of Leaders on board. All of these Leaders and their children were participating in Circles at the end of 2019. All Leaders are individuals or families with incomes less than 150% of the Federal poverty guideline. Under the guidance of the Circles Coach, each cohort of Leaders participates in training for the skills necessary to meeting their goals for financial stability. The Circles Community Coordinator recruits Allies, volunteer intentional friends, who walk with Circles Leaders after they finish their training and move to reach their individual goals for economic stability. Allies receive training in how to be a positive source of encouragement for the Circle Leaders while respecting the leadership roles assumed by the Leader in running his/her Circle of support. Each Leader is matched with two Allies. Every Tuesday night, the Circles community gathers first for dinner and conversation, and then splits into different programs. At the same time the adults are meeting, children participate in age-appropriate curriculum similar to the Leader training. Circles is a relationship-based program and the dinners are lively, filled with conversation and meeting new friends one would normally not have the opportunity to meet. Other volunteers make the Tuesday night meetings go smoothly with greeters, meal preparers, child program volunteers and cleaners. At the end of 2019, Circles RVA had 20 active Leaders, their 24 children and 37 Allies in various stages of the program. The part-time paid staff was supported by 27 meal providers and 110 volunteers who serve on four resource teams.
