the Circles Coach, each cohort of Leaders participates in training for the skills necessary to meeting their goals for financial stability. The first cohort of four Leaders, which started the program in August 2018, graduated in August 2020. As a group, they more than doubled their cash assets, decreased their average individual debt by over \$10,000 and each secured reliable transportation. Four other Leaders in cohorts 2 and 3 worked on goals in the areas of education, career, money management and health during the year. CirclesRVA trained an additional 16 new Leaders. In addition, 41 people completed Ally training. Allies make an intentional commitment to become both cheerleaders and accountability partners for their Circle Leader. CirclesRVA transitioned to virtual meetings and program delivery in March 2020. Volunteers delivered over 2,500 meals and care packages to Leaders.
